## **Course Description and Objectives**

To explore the relationships between the individual and society, it is critical to examine how people interact with their environment. The academic discipline of geography uses an earth systems approach and geographic concepts of place, space, scale, location, regions, and borders to examine humanenvironment interactions. Students will study a broad range of topics, from plate tectonics and climate change to global patterns of population, culture, food security, urbanization, migration, and economy. The overarching emphasis will be on the relationships among these processes. In addition, students will learn how to interpret maps and become familiar with uses of geospatial technologies in research and many aspects of everyday life. The course has ten open-book, online quizzes, two exams, and one final project. Students have plenty of time to finish the quizzes, which are short, straightforward, and mainly used to prepare the exams.

### **Learning Outcomes**

At the end of the semester, students should be able to

- Identify the fundamental concepts and methods of the scientific discipline of geography to explore human-environmental relationships;
- Understand the role of geospatial technologies in shaping contemporary scientific knowledge;
- Describe the dynamics and patterns of environment and natural resources across multiple scales;
- Explain how historical and contemporary, socio-economic, cultural, political, social, and ecological forces interact to influence the nature and location of human activity;
- Use maps, geospatial technologies, and geographic concepts to make inferences and connections between people and their environment.
